- 1. Rose Roy, Board Chair called the virtual meeting to order at 12:08 p.m.**
- 2. Attendance:** Scot Smith called roll. Members and guests introduced themselves and absences for current and future meetings were ratified.
- 3. Minutes:** Pat Kelly moved to approve the minutes for June 10, 2020 and the electronic minutes for June 3, 17 and 24, 2020. Mark Allison seconded the motion. The motion passed unanimously by roll call vote.
- 4. Case Review:** Victims for Transition cases (Delao, Gordon, Wallace, Prine) spoke to the board.
- 5. Program Reports:**
 - a. Sean Foster reported for CAE.
Mr. Foster reported that the facility census was at 199 as a result of decreased CDOC offender movement as a result of the coronavirus pandemic. He stated they had ten escapes and 81 positive drug tests. He stated the increase might be attributed to pandemic impacts, employment and resident coping skills, and increased drug dependency during times of stress and uncertainty.
Mr. Foster stated that case management are working on client employment, cognitive behavioral intervention, and substance abuse treatment to help mitigate unexcused absences and substance abuse. He stated the employment rate in the past has been between 80% and 84% with the rate as low as 59% but is currently at 71.2%.
 - b. Mark Wester reported for CCI.
Mr. Wester reported the facility census at 278 with 56 admission and 50 terminations, with 31 successful and 19 unsuccessful. He reported that escapes were down to ten. He stated they currently have five open positions and hiring for administrative and security techs. Mr. Wester stated their positive UAs were up by 1.2%, and they had a 9.1% positive drug rate up from 7.9 in May. He stated the facility success rates stood at 58% for diversion clients and 56% for transition clients and that staff worked with El Paso County on reporting consistency. He noted that 74% of their clients have jobs representing a rebound from during the height of the coronavirus lockdown. He stated they have closed on a loan for the Robert's Road renovation and expect the project to begin mid-July.
- 6. Department Reports:**
 - a. Financial Report: Scot Smith reported that the at the end of May 2020 the contract with DCJ was at 91.7% expended. ComCor Inc. was 12.4% over expended and CAE was .98% over expended.

- b. Unauthorized Absence Report: Scot Smith reported that the successful completion rate for Diversion clients was at 46.8% at the end of May 2020 and that the unauthorized absence rate for Diversion clients was at 20.5%. He also reported that the successful completion rate for Transition clients was 65% and the unauthorized absence rate for Transition clients was 18%.
 - c. Staff Report: Scot Smith reported CACCB Executive Committee Annual meeting will be virtual and held on July 24, 2020. The CACCB Orientation Meeting will be virtual and held on July 31, 2020. HB 20-1019 calls for escapes to be referred to as unauthorized absences and for the most part to be classified as misdemeanors.

- a. CAE SFY20 Performance Measures Summary: Scot Smith reported that CAE has satisfactorily completed the established performance measures for SFY20.
 - b. CCI SFY20 Performance Measures Summary: Scot Smith reported that CCI has satisfactorily completed all but one of the established performance measures for SFY20; that the measure to complete renovations to 3615 Roberts Road facility is expected to be completed soon.






